HIGH LEVEL SUMMARY ITEMS

- Enrollment and retention numbers are both up
- Revamp of the external facing strategy website and an internal SharePoint are both forthcoming to provide a central hub of information for all things strategy
- Graduation Tuition Benefit proposal offer tuition benefit for employees (not dependents yet) for a maximum of nine credits per academic year; 50% of credit paid for by university, student pays all fees
- Withdrawal Date Deadline proposal propose moving withdrawal date from ~week 10 to ~week 14 of a 16-week semester
- Academic Policy Enactment Policy first read cleaning up policy language and definitions, and aligning with current practices
- Faculty Employment Handbook Policy first read propose adding two additional voting members to committee makeup

- II. President's Update Janine Davidson
 - Enrollment update:
 - Undergrad is up 2% in FTE and up 0.5% in headcount
 - Fall to fall retention is 68.8%, 1.3% better than same time last year;
 - Grad is up 4.9% in FTE and 1.4% in headcount
 - Gave kudos to MSU Denver's ITS team who swiftly responded to the Crowdstrike issue; MSU saw little to no impact thanks to their diligence
 - Protest updates
 - Emphasized that free speech and peaceful protests are rights on campus; disrupting

- the university's mission and fellow students' learning is not
- Student conduct process is mostly complete
- Preparation for upcoming election season
 - MSU Denver Civic Guide refer to and share this resource!
 - Tiger team coordinating on several lines of efforts (see 2024 Election Season Coordination Group / PGM notes below)
 - Friendly reminder that employees cannot use university resources/university name to speak for the university
- Project B is on schedule; West Classroom is open and Sim Labs are opening soon
- Legislative Updates
 - MSU's Board of Trustees (BOT) & Auraris Board of Directors (ABOD) published a resolution in opposition to Initatives 50 & 108
 - These initatives attempt to address the issue of rising property taxes, promising local municipalties that the state will backfill the budget through the general fund, which is how HE gets funded. No guarantee that the state has to fund HE
 - Some anlysis have tuition going up over 40%; schools might have to close or merge; catstrohpic cannot happen
 - Potentially on the ballot (special session in progress to come to a legislative solution/compromise)
 - MSU is in support of a responsible solution that protects higher education

III. Strategy Update – Meredith Jeffers

- Handout provided at Cabinet: August 2024 President Cabinet.docx
- Learned a lot in the last year, including refining OKRs to focus, align, and track goals
- Continuing to improve on the strategic process by focusing on outcomes and aligning objective statemetrs with goals already in strategic plan
- Strategy team is revamping the <u>external facing website</u> and creating an internal SharePoint in response to feedback for a centralized hub of information both ready in September 2024; more information at Sept. Cabinet meeting
- New OKRs are forthcoming
- Seeking feedback on how best to recognize strategy superstars that go above and beyond send feedback directly to Meredith
- Strategic efforts are gaining recognition amongst peers; team is presenting to Colorado Assocation of Non-profits this fall

- Graduate Tuition Benefit (GTB) Proposal
 - Link to Presentation: <u>Partial GBT- PC 08-22-24.pptx</u>
 - Presentation answered questions such as: What is GTB? Who can obtain? What kind of grad education is available? What is the process? Are there any taxes? When will it become available?
 - Now goes to President for final approval
 - Target implementation date is January 1, 2025
- Withdrawal Deadlines SSL Decision Memo
 - Link to Presentation: Withdrawl Date Proposal for Cabinet 8.22.24.pptx

 - Current withdrawal date is set at week 10 (of 16-week course); 67%

- Proposal to move withdrawal date back to week 14 at 85% effective Spring 2025
- Pros:
- Giving students who might "panic" on learning outcomes an opportunity to be successful by giving them more time
- Supporting students
- Cons:
- May be an issue for condensed courses
- SRI consideration students who know they will need to withdrawal due to failing grade can still submit an SRI. May negatively impact instructor's SRI. Need to clarify if students can still fill out an SRI even if they withdrawal
- The norm for the community college system week 13; others is set at week 12
- Need to be thoughtful WHY students withdrawal (DF vs. W rates)
- Provost will take SRIs into consideration but will not hold up the Decision Memo
- Proposed decision timeline Sept 1, 2024
- Share concers no later than Wednesday, August 28 as it moves to President for final action

 - o Part of a regular 5-year review
 - Correction summary grammar, spelling, etc.; clarification to roles/responsibilities; change in the archival process aligning with process that is actually used; added two definitions, some clarifications on procedures on managing and sharing policies
- Faculty Employment Handbook (FEH) Committee Policy
 - o Link to proposed policy: Faculty Handbook Policy DRAFT20231018 (1).pdf
 - Propose a revision to FEH committee composition by adding to additional voting members: (1) from MSU Denver Faculty Federation and (1) additional chair
 - Current committee composition: (2) Faculty Senate, (1) Faculty Trustee, (1) Chair, (1)
 Dean, (2) Academic Officer Representatives non-voting, (1) Faculty Federation non-voting
 - o Pros
 - Since votes are recommendations, not final decisions (final decision lies with President/BOT), by adding two additional voting members records their positions and is a part of the executive summary
 - Faculty Senate voted in favor of addition two additional members; Chairs generally support this, however when separated they did not support the Federation representation but did support the additional chair representation
 - o Cons
 - Concerns around duplication of faculty voice if Faculty Senate already has two votes
 - Deans and Provost are not in favor of additional voting members
 - Questions and concerns around recognizing a group doesn't exisit under law and how that might impact future policies
 - Concerns over the overall structure/makeup of the committee (not any individual person)
- Survey Management Policy

 - O Summary: to minimize survey fatigue, policy proposes a creation of procedures for survey deployment with one centralized calendar

- O Does not include department or college surveys; only university-wide student surveys
- Clarification requested on what approval means
 - This policy would provide conditional approval; suggesting coordination, deconflicting, etc.
- Suggestion of a master timeline of ALL surveys including when all departments are sending surveys
- O Suggestion that this be a process and master calendar rather than a formal policy
